RIBBONS & AWARDS

Placement ribbons will be awarded for first thru fourth place in each class. Blue qualifying ribbons will be awarded to all dogs receiving a qualifying score.

INFORMATION:

A UKC registration number is desired to participate in these trials. For information on UKC registrations go to www.ukcdogs.com

Non-UKC Registered Dog Fee – A \$5 additional fee will be assessed to dogs not Temporarily Listed, Performance Listed, or Permanently Registered with UKC. This fee is to be forwarded to UKC with the event recording fees. Participants whose dogs pass or place have 60 days in which to complete the registration application to UKC. Failure to complete the registration process within the 60 day time period will result in penalty fees being applied to retain points /passes earned. Applicants should include documentation of any points/passes earned when applying for registration papers. Registrations denied will result in no points/passes being credited. UKC reserves the right to change any and all policies, fees, etc., without notice. All major credit cards accepted for registration and DNA testing.

Refunds: Participants may request a full refund before the closing date. After the closing date no refunds will be issued. Substitution Policy: Once a team is notified they are entered, the handler may substitute another dog at the same level.

Valparaiso, IN is on Chicago time - Central Standard Time

Entries must check in 15 minutes before running time. Bring your own water, bowl, crate, chair, etc. **No indoor crating. Restrooms not available on site (5 minute drive). No Food or Water available. This location is not handicap accessible, if you need accommodations for testing, please contact Secretary prior to closing. Location may be a long walk on dirt road, depending on weather conditions.**

Viewing: There will be an area to watch the trials. If you are in the class, do not watch until after you have completed your run. Conversation is acceptable. Do not give the hide away though! No double handling. Do not bring dogs into the viewing area. Viewing is allowed for all runs.

Reactivity: The entrance point will be quite busy, and not conducive to an extremely reactive dog. We are not able to change the environment for a specific dog, as the trial experience should be similar for all entrants. Expect 2 dogs in line for each of the two trial rings, in addition to dogs exiting the ring in the staging area.

HOW TO USE THIS ENTRY FORM

1. All entries must be submitted on the official entry form.
2. You may use one entry form to enter the same dog in more than one field event on the same weekend.
3. Use a separate entry form for each dog to be entered in a club's field events.
4. Mail all completed entry forms plus entry fees to the Event Secretary as listed under the event notice unless otherwise specified.
5. Make all fees payable to the host / club.

REMINDERS

Dogs must be at least 6 months old to be entered in Elite Shed Dog Series events.
 Host / club has right to refuse entry to any dog or handler. However, no handler shall be refused on the basis of religion, race, color, national origin, age or sex.
 All entry forms must be complete and signed. Incorrect information submitted on the entry form may invalidate your pass or placement.

Non-UKC Registered Dog Fee – A \$5 additional fee will be assessed to dogs not temporarily listed, performance listed, or permanently registered with UKC. This fee is to be forwarded to UKC with the event recording fees. Participants have 60 days in which to complete the registration application to UKC to retain passes earned. Failure to complete the registration process and/or registrations denied will result in no pass being credited. Applicants should include documentation of any passes earned when applying for registration papers.

WAIVER

By signing this form containing a release and waiver of all liability and being permitted to participate in the event, I expressly agree to waive the right to assert any claim, action, or lawsuit and expressly agree to release, remise and to indemnify and hold harmless UKC, the sponsoring club/organization and its officers and members, landowners/ property lessors, and any approved UKC Judge or UKC representative from any such claim, action or lawsuit seeking legal damages in any form as a result of participation in this event which might be made or asserted by myself, or which might be asserted on behalf of any minor child or any other person/agent participating in the event on my behalf.
